# Program Overview

Fidelis No Deposit Bonus Promotional Program allows all the MT5 Traders to get 100\$ losable bonus on their Live trading account and start trading with free money.

All MT5 Traders of Fidelis can sign up for Live account and get a No deposit bonus of **100\$**

Experience the power of trading and also enjoy the benefit of profit with Fidelis Live Account without investing.

## A. How to claim your No Deposit Bonus

- I. Open page "Promotions"
- II. Click on "Sign up" for 100\$ No deposit Bonus Account"
- III. Fill and complete the registration form
- IV. Once the registration Process is completed you will be given a Live Account with 100\$ Free Deposit

## B. Program Guidelines

Terms of No deposit Bonus of **100\$**

### 1. General terms

- 1.1. The promotion is valid from 23rd Oct 2018 until further notice from the Company
- 1.2 100\$ no deposit bonus promotion applicable for **India, Srilanka, Malaysia, Pakistan Thailand, Vietnam, Turkey and UAE**
- 1.3 The Company reserves the right to change the promotional Trading Terms and condition.
- 1.4 The Company reserves the right to terminate the Program anytime

### 2. Participants

- 2.1 To claim 100\$ no deposit bonus you should register to promotional Account of Fidelis
- 2.2 To claim profits made on 100\$ client should deposit equivalent amount of profit generated  
*Example – Client made a profit of 300\$ using 100\$ no deposit bonus, hence to claim this 300\$ client should deposit 300\$ on his/her new Rookie Trading account.*
- 2.3 Types of accounts involved in the promotion: No deposit bonus 100\$ account with trading conditions similar to Rookie account.
- 2.4 Only Rookie account type should be opened to claim Profit generated
- 2.5 Identification information is not required while applying for the 100\$ promotional Bonus Account; however, the company reserves the right to ask identification documents at its own discretion
- 2.6 Client account leverage cannot exceed 1:400
- 2.7 The employees of the Company and their families cannot participate in the promotion
- 2.8 Once the participant has been given a Promotional Account with 100\$ Free Deposit, it shall be understood that he/she had read and agreed to the terms and conditions regarding the same
- 2.9 Only a natural person can take part in promotion
- 2.10 Deposits, withdrawal and internal transfer on promotional account are not available

### 3. Getting the bonus

3.1 To receive the bonus get registered by filling up the Registration form available on the Company website and sign up for the promotional account on Client panel.

- I. Fill in the registration form
- II. Once the registration Process is completed you shall be given a Promotional Account with 100\$ Free Deposit

### 4. Withdrawal terms

4.1 The Bonus shall go automatically to the account in case of the compliance with all conditions.

4.2 Bonus is issued once. Reusing of bonus isn't possible.

4.3 Bonus funds are credited for 30 days, after 30 days the bonus is deducted, open positions are closed.

4.4 At the end of 30th day the Bonus of 100\$ will be taken back and the amount of Profit made will be available to the Client on equivalent deposit of profit generated

4.5 As soon as the bonus period of 30 days ends, Client should open new Rookie trading account and make deposit equivalent to his profit generated and trade minimum of 10 lots

4.7 In the absence of deposit within next 30 days all profits are deducted from the account.

4.8 100\$ no deposit bonus is **LOSABLE BONUS NOT WITHDRAWABLE BONUS**

4.9 Partial withdrawal of profit is not allowed.

4.10 Getting bonus and/or trading in bonus funds ON TWO OR MORE ACCOUNTS with same IP-address is prohibited.

4.11 Trading account with the bonus is prohibited to trade through anonymous proxy server. If the account with the bonus will connect with more than 5 different IP-addresses, the bonus will be cancelled.

4.12 Multi Account hedging trade is prohibited in the bonus account. Any suspicious activity will result in immediate termination, In case of violation of this term the Company reserves the right to cancel the bonus and part of the profit earned as a result of the trade.

4.13 Bonus funds are the Company's property.

5.2 All claims on withdrawing profits should include the participant's name and address, trading account number and detailed description of the claim.

## C. Trading Terms

### 30 days Program Trading Terms;

- I. The total bonus of 100\$ will be withdrawn from the promotion account after the completion of 30 days.
- II. The maximum profit/that can be made and claimed under this Program is unlimited.
- III. All the profits made on the Live Trading Account can be claimed only after;
  - The Client deposits equivalent amount of profit generated
  - The Client Trade and complete minimum of **10 lots**

## **D. Example of no deposit bonus Program**

**Mr.FCM 1** new Client of FIDELISCM from India, who have agreed to the Terms and Conditions of this Program and have registered by signing up for the No deposit Bonus on our website and got a Promotional account with 100\$ Free funding.

**Mr.FCM 1** started trading with this 100\$ Free money for 30 days and has made a profit of 300\$ on the live account given and after 30 days the 100\$ bonus has been taken back from the trading account (where he can claim only profit of 300\$ from the promotional account) in order to Claim his Profit of 300\$.

**Mr.FCM 1** has deposited 300\$ (which is equivalent amount of profit made) and achieved 10 Std lots.
